

# Terms and Conditions

## Agreement between User and ShopRxSmartCoffee.com

Welcome to ShopRxSmartCoffee.com. The ShopRxSmartCoffee.com website (the "Site") is comprised of various web pages operated by Rx Smart Coffee ("RXSC").

ShopRxSmartCoffee.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of ShopRxSmartCoffee.com constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

ShopRxSmartCoffee.com is an E-Commerce Site.

You consent to receive electronic communications and you agree that all agreements, notices, disclosures and other communications that we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communications be in writing.

## Your Account

If you use this site, you are responsible for maintaining the confidentiality of your account and password and for restricting access to your computer, and you agree to accept responsibility for all activities that occur under your account or password. You may not assign or otherwise transfer your account to any other person or entity. You acknowledge that RXSC is not responsible for third party access to your account that results from theft or misappropriation of your account. RXSC and its associates reserve the right to refuse or cancel service, terminate accounts, or remove or edit content in our sole discretion.

## Children Under Thirteen

## Cancellation/Refund Policy

### Return/Refund-Buy Back Policy

The goal of Rx Smart Coffee is to ensure that Customers are completely satisfied with their purchases. Upon receipt of any package, it should be examined closely prior to opening the factory-sealed products' packaging. If the order is not in satisfactory, it may be returned provided that the following guidelines are observed:

Returns for "refund" are accepted by the Company only if submitted within 30 days from the order

shipment date. Returns of product for the purposes of “exchange” for other product, are accepted by the Company if submitted within 45 days from the order shipment date. Returns submitted to Rx Smart Coffee after 45 days will only be processed at the discretion of the Company. If there is any concern about return timelines, the Customer is encouraged to contact the Company directly as soon as possible.

All products returned (other than for determination of Defects, as outlined below), must be returned unused, unopened and in resalable condition.

Defective Products: Rx Smart Coffee strives for completely satisfaction of everything offered. This begins from the website all the way to the product selected. That said, “product defects” are carefully scrutinized by Rx Smart Coffee. Any product which is suspected to be “defective” should be immediately returned to Rx Smart Coffee (Please, refer to section B for return procedures) so that Quality Control can examine the product to verify the nature of the defect and recall similar products from similar lot or batch numbers. When a product determined by Rx Smart Coffee to be defective, or otherwise not consistent with Quality Control standards, the Company will immediately replace the product or refund the purchase price. Please DO NOT use the product. Any used or partially used product automatically voids any potential product return.

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.
